MEMBERSHIP TERMS AND CONDITIONS:

1. AGREEMENT

1.1 I ACCEPT THIS DOCUMENT AS A VALID AND BINDING AGREEMENT BETWEEN MYSELF AND TEMPE GYMNASIUM.

2. DURATION

2.1 THIS AGREEMENT IS FOR EITHER 3/6/12 MONTHS, UNLESS I TERMINATE THIS AGREEMENT BY THE DATE OF EXPIRATION OF THE MINIMUM TERM, IT SHALL AUTOMATICALLY BE RENEWED ON A MONTH TO MONTH BASIS.

3. MEMBERSHIP FEES

- 3.1 ON ACCEPTANCE OF THE MEMBERSHIP AT TEMPE GYMNASIUM, I AGREE TO PAY A MONTHLY MEMBERSHIP OF R _____
- 3.2 THE MEMBERSHIP FEE OF EACH MONTH SHALL BE DUE AND PAYABLE ON OR BEFORE THE 7TH OR 15TH DAY OF EACH MONTH
- 3.3 THE MEMBER IS OBLIGED TO PAY REGARDLESS OF WHETHER HE/SHE USES THE GYMNASIUM UNTIL TERMINATION DATE OR CANCELLATION DATE

4. TERMINATION OR CANCELLATION OF MEMBERSHIP

- 4.1 A MEMBER MAY RESIGN FROM THE GYM ON WRITTEN NOTICE AT ANY TIME. THE WRITTEN NOTICE MUST BE GIVEN TO THE GYM AT LEAST 20 BUSINESS DAYS PRIOR TO THE NEXT PAYMENT DATE. THIS MEANS THAT THE MEMBER WILL BE LIABLE TO THE GYM FOR THE VALUE OF THAT MONTH'S MEMBERSHIP FEE. MUST BE CANCELLED AT THE GYM
- 4.2 THE GYM RESERVES THE RIGHT TO CANCEL A MEMBER'S MEMBERSHIP AT ANY TIME

5. EXCLUSION OF LIABILITY AND INDEMNITY

- 5.1 THE GYM SHALL NOT BE HELD RESPONSIBLE OR HELD LIABLE FOR ANY LOSS, DAMAGE OR INJURY INCLUDING CONSEQUENTIAL LOSSES, SUFFERED BY OR CAUSED BY ANY PERSON OR PROPERTY ANYWHERE ON OR ABOUT THE GYM'S PRPERTY OR PREMISIES, WHETHER OR NOT SUCH LOSS, OR ANYONE ELSE FOR WHOSE ACTIONS THE GYM WOULD BE LIABLE IN LAW, OR BY REASON OF THEFT OR BURGLARY WITH OR WITHOUT FORCIBLE ENTRY, OR BY REASON OF ANY CONDITION ON OR OFF THE GROUNDS OF THE GYM, OR ANY DEFECTIVE FACILITIES OF THE GYM, OR CAUSED BY ANY SPORTING ACTIVITY CARRIED OUT ON THE GYM'S PREMISES, OR BY ANY OTHER CAUSES OF WHATSOEVER NATURE AND HOWSOEVER ARISING.
- 5.2 THE MEMBER SHALL, AT ALL TIMES, HOLD THE GYM AND ALL MEMBERS OF THE GYM INDEMNIFIED AGAINST AND HARMLESS FROM AND SHALL IN NO MATTER WHATSOEVER SEEK TO HOLD ANY OF THEM LIABLE FOR ANY INJURY, LOSS OR PATRIMONIAL LOSS ARISING DIRECTLY OR INDIRECTLY FROM PARTICIPATION OF ANY SPORTING ACTIVITY OR THE GYM WHETHER OR NOT SUCH INJURY, LOSS OR DAMAGE CAN BE ATTRIBUTED DIRECTLY OR INDIRECTLY TO NEGLIGENCE OF WHATSOEVER NATURE OR DEGREE ON THE PART OF THE GYM, ANY MEMBER OF THE GYM, AND/OR ANY OF THEIR OFFICIALS, EMPLOYEES AND/ORE AGENTS
- 5.3 THE MEMBER HAS ADVISED THE GYM THAT HE/SHE IS MEDICALLY AND PHYSICALLY FIT TO USE AN EXERCISE PROGRAM AT THE GYM FACILITIES AND THAT HE/SHE HAS CONSULTED A PHYSICIAN WHO HAS APPROVED THEIR USAGE OF THE FACILITIES OF THE GYM AND ANY SPORTING ACTIVITY OFFERED BY THE GYM.

- 6.2 NO VARIATION OF OR ADDITION TO THIS AGREEMENT WILL BE OF FORCE OR EFFECT UNLESS REDUCED TO WRITING AND SIGNED BY OR ON BEHALF OF THE PARTIES.
